Event regulations Exotic animals For exhibitors



- 1. The organizer of the event is the company:

- 2. The opening hours for the visitors' event are: 9:00 am 4:00 pm
- 3. The parking lot for exhibitors is located at the back of the hall, entrance from Stefanowskiego street. Entry to the car park will take place upon presentation of the pass issued by the Organizer via e-mail.
- 4. Application for participation in the Exotic Animals event takes place on the basis of the submitted application form, which takes place only by registration available at www.egzotyczne-zwierzeta.pl in the tab for exhibitors
- 5. The order of submitted applications decides about the participation of Exhibitors.
- 6. Sending the registration form does not constitute the final reservation of seats.
- 7. The organizer has the right to choose and decide which exhibitors will be able to participate in the Exotic Animals event
- 8. The organizer reserves the right to refuse the application without giving any reason.
- 9. After the Organizer accepts the application, the Exhibitor will be obliged to pay the entire proforma specified in the invoice to the Organizer's bank account within 7 days of its receipt.
- 10. The payment of the proforma invoice / payment for the stands is tantamount to confirmation of the exhibitor's participation in the event organized by Exotic Animals Sp z o.o.. The fee is treated as a down payment and is not refundable.
- 11. Failure to pay within the required deadline will result in the Exhibitor being removed from the event.

- 12. The VAT invoice for the paid stand will be delivered to the Exhibitor within 7 days from the end of the event.
- 13. The Exhibitor authorizes the Organizer to issue a VAT invoice without a signature, and to send the invoice by e-mail to the e-mail address provided in the application.
- 14. The stand development plan for Exhibitors is determined by the Organizer.
- 15. The minimum exhibition stand is 180x75 cm with a load capacity not exceeding 100 kg 1 table
- 16.It is forbidden to sublet the stand or its part to persons who were not registered for the event.
- 17. The rented stand is intended only for one exhibitor reported in the form.
- 18. The subletting of the stand by the Exhibitor requires the Organiser's consent.
- 19.Only a natural person and companies running a registered business activity may become an exhibitor
- 20. All persons serving the rented exhibition and event stand should be at least 18 years old and have a valid document confirming their identity and age.
- 21. The Exhibitor has the right to advertise his assortment only at his own rented stand.
- 22. The number of people serving the Exhibitor's stand is:

1-5 tables - 2 people

6-10 tables - 3 people

11+ - 5 people

- 23.Only people who were previously reported in the registration form may stay at the exhibitor's stand
- 24. The stand / Exhibitors should be secured with a material / cloth covering the back from the front.
- 25. The exhibitor should mark his stand with a visible name or logo of the company
- 26.Exhibitors are required to keep the stands they sublet clean
- 27.Exhibitors are obliged to maintain their stands during the hours of the event specified by the organizer.
- 28. Animals exhibited at the event should be in very good condition and appropriate documentation proving their legal origin, registration and possession of appropriate documents or permits by the owners.

- 29. It is forbidden to display and sell animals belonging to the species included in 1 and 2 of the Annex to the Minister's Ordinance of 3 August 2011 on animal species hazardous to human life and health.
- 30.It is forbidden to present animals: transgenic, species considered invasive. European Union Commission Implementing Regulation 2016/1141 OF 13 JULY 2016 . http://eur-lex.europa.eu/legal-content/PL/TXT/?URI=CELEX%3A32016R1141
- 31. The containers in which the animals will be presented should be opaque. The visibility of the animals must be limited to the area of one wall of the container, box, terrarium in order to minimize their stress.
- 32.In connection with Art. 10a sec. 1 of the Animal Protection Act, exhibitors are prohibited from selling vertebrate animals at the event we organize.
- 33. Presented containers should be aesthetic and marked with a logo or company name, as well as signed species and their varieties and gender.
- 34. The Organizer has the right to refuse the Exhibitor's participation in the event if he finds that the exhibitor's actions are unfair or unlawful or inconsistent with the rules of social coexistence, poor condition of the presented animals, too young age or suspicion of unfair practice towards customers and other exhibitors or the Organizer.
- 35.It is not allowed to leave the Exhibitor's stand before the end of the event, it will result in a contractual penalty in the amount of PLN 2,500
- 36.Advertising of the company or other event by the Exhibitor at events organized by Egzotic Animals Sp z o.o. will result in the imposition of a contractual penalty in the amount of PLN 5,000
- 37. During the event, it is strictly forbidden to consume alcohol, intoxicants, and smoke tobacco outside of designated areas.
- 38. Photographing and filming the event is allowed only with the consent of the Organizer.
- 39. Visitors and Exhibitors consent to the Organizer using, free of charge, any photos, films and recordings that may contain their image
- 40.Participation in the Exotic Animals event is full acceptance of these regulations and the content of the GDPR.
